

3.7.2 Functional MoUs



#### **About ST. JOSEPH'S COLLEGE (Autonomous), TIRUCHIRAPPALLI.**

The one hundred and seventy two years old St. Joseph's college, which was founded at Nagapattinam with one student in 1844 by the Fathers of Society of Jesus (The Jesuits) ever before the establishment of the University of Madras in 1958, was later shifted to Tiruchirappalli in 1883. 

#### Today...

St. Joseph's College is an affiliated First Grade College of the Bharathidasan University. It was affiliated to the then Madras University in 1869. The College celebrated its centenary in 1944, sesquicentenary in 1995 and acquired the **Five Star status**, awarded by NAAC in 2000. It was recognized by UGC as a **College with Potential for Excellence (CPE)** in 2004 and was **Re-Accredited by NAAC with A+ Grade** in 2006. The College is **Re-Accredited (3rd Cycle) with A Grade**. The college was awarded with **Star status in 2014**, by the Department of Biotechnology, New Delhi and **DST-FIST Sponsorship**. The college was awarded with **Special Heritage Status by UGC in 2015**. The first department of St. Joseph's recognized to carry out research leading to Ph.D degree was chemistry in 1965, followed by Physics in 1971, Botany and Economics in 1976, English and History in 1982, Tamil in 1986, Human Resource Development in 1987, Mathematic in 1988, Computer Science in 1992, Commerce in 1998, and Statistics in 2001. At present, the College is offering full time research programmes leading to M.Phil and Ph.D., both in arts and science subjects and so serving the society at large by promoting research and development.

#### ABOUT SCHOOL OF BIOLOGICAL SCIENCES


The history of the Botany department of this college dates back to 1912, when the study of *Natural Science* was introduced at the Intermediate courses. Rev. Fr. Gombert, SJ, was guiding the Botany and Zoology sections. The Students of the Natural Science stream occupied the top slots in the medical and engineering centers of the country. The *Botany* course appeared in 1930 as an ancillary subject to the B.Sc., and B.A., major courses. From 1952 onwards Rev. Fr. Rapinat was pioneering the department in the early periods. Under his guidance the B.Sc., degree Botany course



was started in 1952. He made extensive collections of plants and preserved them in the herbarium. He equipped the laboratories and library with a view to start post-graduate course. The M.Sc., degree in Botany was introduced in 1958, and the department was the first to offer it outside the Madras city in Tamil Nadu. Reading the signs of times and demand generated for job oriented modern programs the department of Botany took the initiative to offer M.Sc., Biochemistry as an interdisciplinary course in 1992. Later in 2001, M.Sc., Biotechnology course was started. Projects funded by UGC, DST, CSIR, DBT, MoEF and NMPB have been sanctioned.

### **About Indian Institute of Crop Processing Technology (IICPT)**

The Indian Institute of Crop Processing Technology (IICPT) is a pioneer Research and Development Institute under the Ministry of Food Processing Industries, Government of India. The Institute has its origin way back in 1967 when it was started as an R & D laboratory for identifying technologies for paddy processing and preservation. From 1972 it was known as Paddy Processing Research Centre (PPRC). Considering the vital importance of strengthening R & D efforts in the post-harvest processing of foods in the country, the Ministry strengthened and upgraded the PPRC as a National Level institute and renamed as Indian Institute of Crop Processing Technology (IICPT) from February 2008. The IICPT is located in the outskirts of the city of Thanjavur in Southern India, a paddy hub for the country. The mandates of IICPT include conducting basic, applied and adoptive research and development in post harvest processing, preservation and value addition of cereal grains, pulses, millets and oil seeds, and crops of wetlands and storm prone regions, including plantation, spices and other important crops, bringing the technologies to the stake holders through training and seminars and human resource development in the areas of food processing technologies. IICPT is offering B.Tech., M.Tech., and Ph.D. in Food Process Engineering and M.Tech in Food Science and Technology.



Research and academic exchanges are considered here to include but not limited to:

1. **Reciprocal assistance for visiting faculty and students,**
2. **Coordination of lectures and training,**
3. **Development of mutually beneficial research programmes, and**
4. **Utilization of instrumental facilities for analysis of samples on charge basis.**

Activities pursuant to this understanding may involve any discipline to the extent that individuals are able to locate suitable counterparts at the partner institution.

Prior to implementing, individual visits of faculty members, representatives of both institutions shall secure approvals from their respective competent authority.

Office space, academic and research facilities provided to visiting faculty members shall be made by the respective department chairs or heads in consultation with the visiting faculty members.

The transfer of information, faculty, or staff for education, research or related activities shall be proposed by both institutions through their faculties and units, in consultation with and approval of the appropriate institutional officials, and shall be the subject of a separate document.

Both institutions/representatives may strictly maintain confidentiality and to prevent disclosure of the information.

IP rights shall rest with both institutions on equal credit and right basis whenever new product or process developed under any research/related activities.

All specific projects to which this Memorandum of Understanding may lead shall be evaluated on a regular basis by the designated authorities of both institutions.

For conditions of the linkage and terms of agreement not covered by this memorandum of understanding or for problems which arise while the exchange agreement is in effect, both parties agree to refrain from unilateral action, to consult with each other and to negotiate mutually agreeable decisions. Both institutions subscribe to the policy of equal opportunity and will not discriminate on the basis of gender, age, disability, race, color, religion, marital status, veteran's status, national or ethnic origin, or sexual orientation.



This Memorandum of Understanding will become effective immediately. It shall continue in effect for a period of Five (5) years and may be extended by mutual agreement. It may be terminated by either institution upon three months written notification to the partner institution.

(Hereinafter referred to as SJC, Trichy)

Annamalai Nagar, Woraiyur, Tiruchirappalli, Tamil Nadu - 620 002

The activities undertaken pursuant to this Memorandum of Understanding (MOU) are based on a spirit of cooperation and reciprocity that is intended to be of mutual benefit to both parties. This is a non-binding agreement and is intended to elucidate the nature and extent of the complementary activities that might be undertaken for the mutual benefit of IADC-A and SJC, Trichy.

1. Both parties are engaged in education and research, and wish to commence and continue their common interest by developing and enriching academic and research exchanges between the two institutions.
2. Both parties, in pursuance of the common intent to disseminate and advance knowledge intend providing instructional, research and extension facilities to each other in all related disciplines and thus develop academic and scientific relationship between the two institutions.
3. The collaboration between the two institutions envisaged by this MOU are:
  - i. Collaborative research, instructional, cultural and extension programmes.
  - ii. Exchange of research information.
  - iii. Student Exchange Programmes.
  - iv. Faculty and Staff exchange programmes.
4. This MOU proposes the following concrete activities in realizing the below given programmes:
  - i. Conducting Seminars and Workshops on research-related areas.
  - ii. Organizing awareness programmes and conferences in field of mutual interest.
  - iii. Exchange of scientific publications.
  - iv. Exchange of personnel as Resource Persons.
  - v. Sharing laboratory and library facilities for research activities.
  - vi. Providing facilities for analysis at concessional rates.
  - vii. Sharing facilities for research students to carry out their projects.
  - viii. Organizing exchange programmes for both Staff and Students.
  - ix. Conducting periodic meetings of concerned personnel to promote better understanding between the two institutions.

## ADMINISTRATION OF THE MOU

5. The administration of this MOU will be subject to the following conditions and limitations:

- i. The implementation of any of the programmes or activities envisaged by this MOU shall depend upon the availability of material and financial resources in the institutions concerned.
- ii. The specific of the programmes and activates shall be designed and carried out by the authorized representatives of IADC-A and SJC, Trichy.
- iii. The work performed under this MOU will be reviewed on an annual basis. The meetings will be held in a location and on a day that are convenient to both the institutions.
- iv. Each institution to this MOU shall own the intellectual property (IP) conceived of first reduced to practice solely by its employees or agent. Further the intellectual property conceived and reduced to practice through joint efforts of both the institutions shall be shared by both with regard to project or activities contemplated by this MOU.
- v. Each institution pledges not to use the name of other party or the name of any employee of other institution, in any publicity, advertising or news release without the prior written approval of the institution.


For agreed upon activities, both institutions will make available their facilities and staff members. This MOU will take effect on and will be valid for three (3) years from the date noted in the first line of this document unless terminated by one of the parties. Either party may withdraw from this MOU provided written notification of the withdrawal is given to the other party at least three (3) months prior to the desired withdrawal date. This MOU may be renewed for another period of three (3) years upon mutual written consent of the parties before the expiration date. Each institution will have copies of this agreement.

There is no financial commitment on the part of IADC-A and SJC, Trichy to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

Additions or amendments to the provisions fixed by this Memorandum of Understanding are possible at any time, subject to consultation and agreement between both parties.



## Article 1. Scope

The Second party will recognize the First party as an Institute for conducting research related to the thesis requirement of the research students for M.Phil Biotechnology. The Second party will recognize Scientists of the ICAR Institute as recommended by its Director in accordance with the University rules and regulations for guiding students working for the said degree.

Operational details of research effort and collaboration will be made in common research programmes and/or projects restricted to specific mandated domain within the approved disciplines/divisions. The objective(s) for research work for a student coming from a Second party outside NARS should be exclusively different as far as possible.

Research instrumentation facility and library facilities available with the First party and the Second party will be made available to the faculty and research scholars. However, the costs of specific consumables will be borne by the respective organizations.

There shall be an exchange of students for academic, research and training purposes. Accommodation in the Hostel shall be arranged, wherever possible, as per extant rates. The duration of exchange visits will be determined by mutual consent between both the parties.

## Article 2. Management

Director of the First party and the Vice-Chancellor/Head of the Institution of the Second party will be responsible to work out operational details of co-operation between the two organizations and ensure proper and effective implementation of this MoU.

The Advisory Committee will meet at least once in a year alternatively in the institutions of the First party and the Second party to review the activities. This meeting shall include presentation on the academic and research activities, which should be open to the students, faculty and scientists.

## Article 3. Exchange of Information

The term "information" includes scientific or technical data, results and/or methods of investigation, and other information intended to be provided, exchanged, or arising under project descriptions entered into pursuant to this MoU.

The parties support the widest possible dissemination of information. Each party in joint projects shall be given the right to use, disclose, publish or disseminate such information for any and all purposes.

#### Article 4. General Provisions

It is understood that the First party and the Second party subscribe to the principle of equal opportunity and do not discriminate on the basis of race, sex, age, caste or religion. Both the Institutions shall abide by these principles in the administration of this agreement and neither party shall impose criteria for exchange of scholars or students, which violate principles of non-discrimination.

Both parties understand that all financial agreements will have to be negotiated separately and will depend on the availability of funds.

Both parties acknowledge that exchange of students from one party to the other shall be subject to the availability of funds and shall comply with the regulations and policies of the First party and the Second party.

Any research publications arising will be jointly published in accordance with the provisions laid out in Item 3.2.1C of the Guidelines for the students to conduct research for their degree programme as trainees at ICAR institutions as notified *vide* Letter No. 2-8/2012-HRD dated 25<sup>th</sup> April, 2014 or revised guidelines, if any, as may be issued from time to time.

A copy of the thesis/dissertation will be submitted to the First Party after the award of the degree by the Second party.

All questions related to this MoU arising during its term will be settled by the parties by mutual agreement. Disagreements at the operating level shall be forwarded to respective higher officials for appropriate resolution failing which an arbitrator of mutual acceptance may be identified for the settlement of dispute, if any.

All questions not foreseen related to this MoU will be handled by the parties by mutual agreement.

Nothing in this MoU is intended to affect other cooperation or collaborations between the parties.

#### Article 5. Intellectual Property Rights

- 5.1 The Second party will be expected to ensure protection of the Intellectual Property Rights generated or likely to be generated during the student's research work. The ICAR as the first applicant (for its institute) and the Second party shall be the joint applicants for IPRs and the students and involved scientific staff shall be included as the inventor/breeder/author. The 'ICAR Guidelines for Intellectual Property Management and Technology Transfer/Commercialization' as amended from time to

time shall be the reference for exploitation of the generated intellectual property, whose management and benefits sharing shall be mutually decided in each case.

#### Article 6. Admission and Fees

All those who wish to register as trainees or for Master/Doctoral programme under this MoU must apply for admission at the Second party. The allocation of Major Guide/Advisor would be finalized before the registration and will be governed by the provisions laid out in Items 3.2.1A and 3.2.2A of the Guidelines for the students to conduct research for their degree programmes as trainees at ICAR institutions as notified *vide* Letter No. 2-8/2012-HRD dated 25<sup>th</sup> April, 2014 or revised Guidelines, if any, as may be issued from time to time, for the students from within NARS and outside NARS, respectively.

Admission of the students and the award of degrees for different programmes will be the responsibility of the Second party as per the rules and regulations.

Allotment of the students at the First party will be done by the approval of Director of the First party and Vice-Chancellor/Head of the Institution of the Second party.


The First party would have the right to screen the student's eligibility for admission based on their academic period.

The PME Cell of the First party in consultation with the representative of the Second party shall decide the location and sharing quantum of research work.


The number of student(s) at any particular time will be subjected to the availability of research facilities and scientists' time to guide thesis research at the First party institution.

Any student(s) admitted to the First party for training/postgraduate research, if found violating the rules and regulations laid down by the First party or indulge in such activities that amount to tarnishing the image of the Institute, or cause damage to the property, the registration of such student(s) would be summarily terminated. The Second party will not complete the formalities of issuing the certificates to such students until they compensate the losses to the First party.

The fee structure is to be reviewed periodically after two years by the AU/DU or the ICAR Institute, as the case may be. However, the students may be charged a fee of Rs.10,000/- for training duration of three months not leading to a dissertation/ degree.

#### **Article 7. Entry into effect, modification and termination**

1. ## Memorandum of Understanding

**Commencement Date:** the last date of signature by both parties of this document being 27<sup>th</sup> – February 2020

**Association of Chartered Certified Accountants**, incorporated by Royal Charter (number RC000732) of The Adelphi, 1–11 John Adam Street, London WC2N 6AU ("ACCA")

### 1. Background

- 1.1. This Memorandum of Understanding (MOU) made between the St. Joseph's College, Tiruchirappalli and ACCA provides for the establishment of a mutual co-operation between these two institutions.
- 1.2. Recognising the value of promoting mutual co-operation for the advancement of their respective members and the accountancy and tax professions, St. Joseph's College, Tiruchirappalli and ACCA agree to the following terms as set out below.

### 2. Purpose

- 2.1. The purpose of this MoU is to set out the understanding between the Parties without any intention to create legal relations, rather in the spirit of mutual cooperation. Any collaborative ventures that may bind the Parties are subject to separate contractual arrangements. The purpose of this MoU is to explore opportunities for collaboration to their mutual benefit, to set out the respective roles and responsibilities of the Parties in working cooperatively to further each other's and their mutual interests.
- 2.2. No funding will be required from either Party except as mutually agreed from time to time. The Parties agree that all financial arrangements will be negotiated for each specific case prior to commencement of the activity and will depend on the availability of funds.

### **3. Duration and Termination**

- 3.1. This MOU will be deemed to have come into force and effect on the Commencement Date and will continue for a period of three (3) years from that date. The parties agree to review this MOU annually. This MOU may be terminated at any time during its term by either ACCA or St. Joseph's College, Tiruchirappalli upon three (3) months' prior written notice to the other.
- 3.2. Either party may terminate this MOU by immediate written notice to the other party in the event of an occurrence of any act, omission or conduct which is deemed by the Terminating Party, at all times acting reasonably, to undermine, jeopardise or damage the professional reputation of the Terminating Party.
- 3.3. This MOU may be amended upon the mutual written agreement of both parties.

### **4. Specific areas of co-operation**

ACCA undertakes to work together with St. Joseph's College, Tiruchirappalli in the following areas:

- 4.1. Provide access to ACCA professional development and learning resources
- 4.2. Learning and development initiatives - e.g. competencies, skills and training mapping, etc.
- 4.3. Jointly develop strategies and marketing campaigns to promote the global collaboration between St. Joseph's College, Tiruchirappalli and ACCA
- 4.4. Work collaboratively and carry out joint engagement and outreach to promote and create awareness about ACCA trainings, Qualification, ACCA-X, master's programme and other relevant trainings
- 4.5. Joint partnership programmes supporting the training and development of students to prepare them for successful careers in accountancy and finance;
- 4.6. Explore and create new pathways for students to further their education and enhance their careers in accountancy and finance;
- 4.7. Enhance the employability of students through capacity building initiatives;
- 4.8. Tap into one another's networks of professional and industry contacts to support the above objectives

### **5. Other areas of co-operation**

St. Joseph's College, Tiruchirappalli and ACCA will also explore other potential areas where co-operation would be of mutual benefit.

## **6. Confidentiality**

The parties agree to keep confidential any information which is disclosed or obtained and which is not publicly available or already known and not to disclose such information to third parties, otherwise than in accordance with the consent of the other party or as required by law or any relevant regulatory authority.

## **7. Anti-bribery and Anti-Slavery Measures**

- 7.1. Each Party undertakes to the other to comply with applicable laws, regulations, codes and sanctions relating to anti-bribery and anti-corruption and each other's respective anti-bribery and gift and hospitality policies (where applicable) as may be amended from time to time, copies of which will be provided on written request.
- 7.2. Each party shall ensure that it and any persons or subcontractors involved in the delivery of the objectives of this MOU shall comply with all applicable anti-slavery and human trafficking laws, statutes, regulations and codes from time to time in force.
- 7.3. Breach of this part 7 shall be deemed to be a material breach and in case either party breaches this part 7, the non-breaching party may terminate the MOU immediately by written notice.

## **8. Intellectual Property Rights**

- 8.1. All intellectual property content that is developed jointly by the Parties after the commencement of this MOU will be jointly owned by the Parties and subject to any other terms and conditions that will be worked out on a case-to-case basis, as may be agreed upon in writing.
- 8.2. Any intellectual property that is owned by either of the Parties, pre dating this agreement, and is exploited or modified under this MOU, will remain the sole property of that Party. It will therefore not be reproduced or transmitted in any other form or by any other means, electronic or mechanical, including photocopying, recording on any storage or retrieval system, without the prior permission and written consent of the intellectual property owner.
- 8.3. Use of logos, trademarks, intellectual property, copyright materials, etc. will be in accordance with each organisation's guidelines. Neither Party shall use, nor permit any person or entity to use the name, logo (or any variation thereof), intellectual property, copyright materials, etc. of the other party without first obtaining the other Party's written consent.

## **9. Assignment**

Unless this MOU expressly states otherwise, no right or obligation arising under this MOU may be assigned, transferred or otherwise disposed of, in whole or in part, without the prior written agreement of the parties.


## 10. Form of Understanding





## **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding is entered into at Madurai on this 18 day of December in the Year 2019.

### **BETWEEN:**

**ISDC Projects India Pvt. Ltd.**, trading as **ISDC - International Skill Development Corporation**, and having its Regional Office at Lakshmi Narayan Complex, Palace Road, Vasanth Nagar, Bengaluru, Karnataka - 560052 represented by its Head- Institutional Partnerships – Mr. Daya Murthy, hereinafter referred to as "ISDC" or the **FIRST PARTY**

### **AND**

**St. Joseph's College** is a Bharathidasan University-affiliated college located in College Main Road, Annamalai Nagar, Teppakulam, Tiruchirappalli, Tamil Nadu 620002. The College is autonomous and has an independent examination and recognition system; represented by its Principal Rev. Dr. M. Arockiasamy Xavier, S.J, hereinafter referred to as "St. Joseph College" or the **SECOND PARTY**

Both parties as above have expressed a desire of entering into a Memorandum of Understanding to meet their respective objectives, which are set out herein below.

### **WHEREAS**

- a. The First Party- ISDC, a Skill Development & Education Company having expertise in Professional and Vocational Education and is interested in associating with the Second Party to develop, promote and deliver B.Com (Honours) Integrated with ACCA, which is accredited by the ACCA (Association of Chartered Certified Accountants), UK Professional Body in Chartered Accountants.



- b. The Second Party on its part is interested in associating with First Party for using their expertise to develop, promote and deliver the course mentioned above as the Undergraduate program of St. Joseph College with their Academic Autonomy and which leads to Advanced Diploma from ACCA to the students enrolled with the Second Party along with their Undergraduate degree from St. Joseph College.

The purpose of this Memorandum of Understanding is to set forth the terms and conditions under which the Parties to this understanding shall conduct themselves during the subsistence of the Memorandum.

This Memorandum of Understanding ("MOU") is not intended to be, legally binding except as specifically set out below.

1. The First Party shall support the Second Party to develop the undergraduate course mentioned in the First Part (Part A) of this MoU. The Students enrolled for this course/program leads to the additional qualification / Membership from the respective professional organization as mentioned above (Part B).
2. It is the responsibility of the Second Party to get the necessary approvals for running the program at St. Joseph College. The final approved syllabus by the Board of Studies and Academic Council of the institution for the Course/ Program with the exemptions availed from professional body through program accreditation process will be given as Annexure 1.
3. The First party can use the name of the St. Joseph College for promoting the above program in advertisements and other modes of communications. The Promotion of the said program has to be taken-care jointly by the parties.
4. The admission criteria and the number of seats for the above said programs are fixed by the Second Party in consultation with First Party.



5. The First Party facilitates train the trainer program for 8 hours per paper of ACCA to the Faculties of the Second Party, as per mutually agreed time schedule.
6. The First Party provides Electronic Copy as well as limited printed copy for reference of relevant learning materials (For the subjects of integrated curriculum of professional body only) to the students enrolled for the above said Course/Program
7. The First Party provides training support to the students enrolled for the above program and the number of hours per subject / paper/module is given as Annexure 2.
8. All responsibilities regarding registration of the students with professional body should be dealt with, by the First Party. The students have to follow the Rules and Regulations of Respective Professional body to appear the examination and pursue the qualification/ membership and designation.
9. The relevant fee to professional bodies has to be paid by the students directly as per the rules and regulations set by the professional bodies time to time as per Annexure 3.
10. Out of the Tuition Fees Collected, the Second Party has to make the necessary payment to the First party as per the table given below:

Course/Program	Amount
B.Com (Honours) Integrated with ACCA	INR 36,000 Per Student for entire three years
First Installment - After admission confirmation and course commencement in 2020	INR 18,000
Second Installment – Before February 28, 2021	INR 18,000

*This is for the Batch of 2020-2021 while the same will continue for subsequent fresh batches. The above fee will be a part of the college fee.*



11. The complete list of Students of the course shall be provided to the First Party by the Second Party. Changes in Students, if any, shall be communicated by the representative of the Second Party to the First Party immediately.
12. It is intended that the terms of this MoU will remain in force for an initial period of three years set out above i.e., the completion of First Batch or is otherwise terminated in accordance with the provisions of Clause 13. The MoU can be extended for further periods after the expiry of three years upon the parties mutually agreeing such extension in writing. The terms of this Memorandum may be modified at any time by both parties on mutual consent.
13. Either party shall be entitled to terminate the MOU on 60 days' notice. The MoU will automatically terminate:
  - Any potential Binding Agreement would be unenforceable, void or illegal due to any statutory or regulatory requirements; or
  - Terminates any Binding Agreement for cause.
  - In the event of the termination of the agreement, the First Party agrees to complete the existing batches on agreed terms.
14. All intellectual property created by a party in connection with the collaboration shall remain the property of that party. The parties agree that any material jointly created by the parties for the collaboration shall be jointly owned (in equal proportions) by the parties, unless otherwise agreed in writing.
15. Where the collaboration reasonably requires the use by one party of intellectual property that is owned by the other party (the "IPR Owner"), the IPR Owner will license such rights to the other party on a non-exclusive basis, without the right to sub-license, solely for the purpose and to the extent necessary in connection with the collaboration. Any such license will automatically terminate when the MoU is terminated.



16. The college will comply by providing the required documents for ACCA Accreditation, academic program guide with details of the Integrated syllabi and sample question papers.
17. For the purposes of this MoU, "Confidential Information" shall be all information of a confidential nature (whether written or oral) concerning the business and affairs of either party which is obtained or received as a result of the discussions leading up to, the entering into or the performance of this MoU, including financial information, training & learning material, trade secrets, college lists, trade and commercial details and computer software and databases, the contents of all reports and documentation prepared by either party or on its behalf and any other information of a confidential nature designated by a party as confidential; Each of the parties shall at all times while this MoU remains in force and after it has terminated, keep confidential the Confidential Information except where:
- The Confidential Information was already lawfully known, or became lawfully known to either of the parties independently;
  - Disclosure or use is necessary by either of the parties (including their employees, agents and sub-contractors) for the proper and effective performance of this MoU;
  - Disclosure is required by law to any government, governmental department, agency, regulatory or fiscal body or authority (whether national or foreign) and their authorized agents (including professional advisers);
  - The Confidential Information is disclosed, in the case of ISDC, to another member of the ISDC group of companies;
  - Each party undertakes to the other that it will not disclose or make use of, for its own benefit, any of the Confidential Information of that other party.
18. All disputes and differences of any kind whatever arising out of or in connection with this MoU shall be referred to the arbitration, and the final decision of an arbitrator Jointly appointed by both the parties to be agreed upon and appointed by both the parties, or in case of disagreement as to the appointment of a single arbitrator, two arbitrators, one to be appointed by each party and if there are two arbitrators, they shall before taking upon themselves the burden of reference appoint a third arbitrator



who shall act as Presiding Arbitrator. This submission to the arbitrators shall be deemed to be a submission to arbitration within the meaning of the **Arbitration and Conciliation Act, 1996**, or any statutory modification thereof. The award of the arbitrator or arbitrators as the case may be, shall be final and binding on the parties.



2. Implementation


- a) This memorandum is effective for five years from the date of signing, unless terminated earlier by any one of the parties.




