SUMMARY OF THE ACTIVITIES

Admissions:

As proposed and directed by the Madurai Jesuit Higher Education Commission and following the direction of Fr Provincial, admission committee is constituted. Fr Sebastian Anand SJ was the Admissions Officer for this year. The members are:

This Committee met periodically with a view to providing admission according to the province norms and preferential option for the poor, similarly fulfilling the Government norms and regulations. Fr M Devasagayam SJ, Dalit Coordinator was present at all the sessions. Details of the admissions are given separately.

Taking the clue from the last year's admissions, we have this year admitted a large number of people from the marginalised sections of the society. College's aims were kept in mind in the matters regarding the admission. An increasing number of catholics and more especially the Dalit catholics found a place in the admission list.
