#### Memorandum of Understanding

**Commencement Date:** the last date of signature by both parties of this document being 27<sup>th</sup> – February 2020

**Between** St. Joseph's College (Autonomous), Tiruchirappalli-620 002, Tamilnadu, India.

and

**Association of Chartered Certified Accountants**, incorporated by Royal Charter (number RC000732) of The Adelphi, 1–11 John Adam Street, London WC2N 6AU ("ACCA")

#### 1. Background

- 1.1. This Memorandum of Understanding (MOU) made between the St. Joseph's College, Tiruchirappalli and ACCA provides for the establishment of a mutual co-operation between these two institutions.
- 1.2. Recognising the value of promoting mutual co-operation for the advancement of their respective members and the accountancy and tax professions, St. Joseph's College, Tiruchirappalli and ACCA agree to the following terms as set out below.

#### 2. Purpose

- 2.1. The purpose of this MoU is to set out the understanding between the Parties without any intention to create legal relations, rather in the spirit of mutual cooperation. Any collaborative ventures that may bind the Parties are subject to separate contractual arrangements. The purpose of this MoU is to explore opportunities for collaboration to their mutual benefit, to set out the respective roles and responsibilities of the Parties in working cooperatively to further each other's and their mutual interests.
- 2.2. No funding will be required from either Party except as mutually agreed from time to time. The Parties agree that all financial arrangements will be negotiated for each specific case prior to commencement of the activity and will depend on the availability of funds.

### **3. Duration and Termination**

- 3.1. This MOU will be deemed to have come into force and effect on the Commencement Date and will continue for a period of three (3) years from that date. The parties agree to review this MOU annually. This MOU may be terminated at any time during its term by either ACCA or St. Joseph's College, Tiruchirappalli upon three (3) months' prior written notice to the other.
- 3.2. Either party may terminate this MOU by immediate written notice to the other party in the event of an occurrence of any act, omission or conduct which is deemed by the Terminating Party, at all times acting reasonably, to undermine, jeopardise or damage the professional reputation of the Terminating Party.
- 3.3. This MOU may be amended upon the mutual written agreement of both parties.

### **4. Specific areas of co-operation**

ACCA undertakes to work together with St. Joseph's College, Tiruchirappalli in the following areas:

- 4.1. Provide access to ACCA professional development and learning resources
- 4.2. Learning and development initiatives - e.g. competencies, skills and training mapping, etc.
- 4.3. Jointly develop strategies and marketing campaigns to promote the global collaboration between St. Joseph's College, Tiruchirappalli and ACCA
- 4.4. Work collaboratively and carry out joint engagement and outreach to promote and create awareness about ACCA trainings, Qualification, ACCA-X, master's programme and other relevant trainings
- 4.5. Joint partnership programmes supporting the training and development of students to prepare them for successful careers in accountancy and finance;
- 4.6. Explore and create new pathways for students to further their education and enhance their careers in accountancy and finance;
- 4.7. Enhance the employability of students through capacity building initiatives;
- 4.8. Tap into one another's networks of professional and industry contacts to support the above objectives

### **5. Other areas of co-operation**

St. Joseph's College, Tiruchirappalli and ACCA will also explore other potential areas where co-operation would be of mutual benefit.



## **6. Confidentiality**

The parties agree to keep confidential any information which is disclosed or obtained and which is not publicly available or already known and not to disclose such information to third parties, otherwise than in accordance with the consent of the other party or as required by law or any relevant regulatory authority.

## **7. Anti-bribery and Anti-Slavery Measures**

- 7.1. Each Party undertakes to the other to comply with applicable laws, regulations, codes and sanctions relating to anti-bribery and anti-corruption and each other's respective anti-bribery and gift and hospitality policies (where applicable) as may be amended from time to time, copies of which will be provided on written request.
- 7.2. Each party shall ensure that it and any persons or subcontractors involved in the delivery of the objectives of this MOU shall comply with all applicable anti-slavery and human trafficking laws, statutes, regulations and codes from time to time in force.
- 7.3. Breach of this part 7 shall be deemed to be a material breach and in case either party breaches this part 7, the non-breaching party may terminate the MOU immediately by written notice.

## **8. Intellectual Property Rights**

- 8.1. All intellectual property content that is developed jointly by the Parties after the commencement of this MOU will be jointly owned by the Parties and subject to any other terms and conditions that will be worked out on a case-to-case basis, as may be agreed upon in writing.
- 8.2. Any intellectual property that is owned by either of the Parties, pre dating this agreement, and is exploited or modified under this MOU, will remain the sole property of that Party. It will therefore not be reproduced or transmitted in any other form or by any other means, electronic or mechanical, including photocopying, recording on any storage or retrieval system, without the prior permission and written consent of the intellectual property owner.
- 8.3. Use of logos, trademarks, intellectual property, copyright materials, etc. will be in accordance with each organisation's guidelines. Neither Party shall use, nor permit any person or entity to use the name, logo (or any variation thereof), intellectual property, copyright materials, etc. of the other party without first obtaining the other Party's written consent.

## **9. Assignment**


Unless this MOU expressly states otherwise, no right or obligation arising under this MOU may be assigned, transferred or otherwise disposed of, in whole or in part, without the prior written agreement of the parties.

#### 10. Form of Understanding

- 10.1. This MOU outlines the areas of co-operation that have been agreed between St. Joseph's College, Tiruchirappalli and ACCA, however nothing in this MOU should be construed as creating legal obligations between the two parties, except for clauses 6 (Confidentiality), 7 (Anti-bribery Measures) and 8 (Intellectual Property). This MOU supersedes any previous agreement between the parties relating to its subject matter.

#### 11. Good Faith

- 11.1. In entering into this MOU, the parties recognise that it is impractical to make provisions for every contingency that may arise during the course of the MOU.
- 11.2. Accordingly, the parties declare it to be their intention that this MOU shall operate between them in accordance with the principles of good faith, with fairness and without detriment to the interests of anyone and if any dispute arises, the parties shall use commercially reasonable endeavours to agree upon such action as may be necessary and equitable to remove or resolve the cause or causes of the same.



## **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding is entered into at Madurai on this 18 day of December in the Year 2019.

### **BETWEEN:**

**ISDC Projects India Pvt. Ltd.**, trading as **ISDC - International Skill Development Corporation**, and having its Regional Office at Lakshmi Narayan Complex, Palace Road, Vasanth Nagar, Bengaluru, Karnataka - 560052 represented by its Head- Institutional Partnerships – Mr. Daya Murthy, hereinafter referred to as "ISDC" or the **FIRST PARTY**

### **AND**

**St. Joseph's College** is a Bharathidasan University-affiliated college located in College Main Road, Annamalai Nagar, Teppakulam, Tiruchirappalli, Tamil Nadu 620002. The College is autonomous and has an independent examination and recognition system; represented by its Principal Rev. Dr. M. Arockiasamy Xavier, S.J, hereinafter referred to as "St. Joseph College" or the **SECOND PARTY**

Both parties as above have expressed a desire of entering into a Memorandum of Understanding to meet their respective objectives, which are set out herein below.

### **WHEREAS**

- a. The First Party- ISDC, a Skill Development & Education Company having expertise in Professional and Vocational Education and is interested in associating with the Second Party to develop, promote and deliver B.Com (Honours) Integrated with ACCA, which is accredited by the ACCA (Association of Chartered Certified Accountants), UK Professional Body in Chartered Accountants.



- b. The Second Party on its part is interested in associating with First Party for using their expertise to develop, promote and deliver the course mentioned above as the Undergraduate program of St. Joseph College with their Academic Autonomy and which leads to Advanced Diploma from ACCA to the students enrolled with the Second Party along with their Undergraduate degree from St. Joseph College.

The purpose of this Memorandum of Understanding is to set forth the terms and conditions under which the Parties to this understanding shall conduct themselves during the subsistence of the Memorandum.

This Memorandum of Understanding ("MOU") is not intended to be, legally binding except as specifically set out below.

1. The First Party shall support the Second Party to develop the undergraduate course mentioned in the First Part (Part A) of this MoU. The Students enrolled for this course/program leads to the additional qualification / Membership from the respective professional organization as mentioned above (Part B).
2. It is the responsibility of the Second Party to get the necessary approvals for running the program at St. Joseph College. The final approved syllabus by the Board of Studies and Academic Council of the institution for the Course/ Program with the exemptions availed from professional body through program accreditation process will be given as Annexure 1.
3. The First party can use the name of the St. Joseph College for promoting the above program in advertisements and other modes of communications. The Promotion of the said program has to be taken-care jointly by the parties.
4. The admission criteria and the number of seats for the above said programs are fixed by the Second Party in consultation with First Party.





5. The First Party facilitates train the trainer program for 8 hours per paper of ACCA to the Faculties of the Second Party, as per mutually agreed time schedule.
6. The First Party provides Electronic Copy as well as limited printed copy for reference of relevant learning materials (For the subjects of integrated curriculum of professional body only) to the students enrolled for the above said Course/Program
7. The First Party provides training support to the students enrolled for the above program and the number of hours per subject / paper/module is given as Annexure 2.
8. All responsibilities regarding registration of the students with professional body should be dealt with, by the First Party. The students have to follow the Rules and Regulations of Respective Professional body to appear the examination and pursue the qualification/ membership and designation.
9. The relevant fee to professional bodies has to be paid by the students directly as per the rules and regulations set by the professional bodies time to time as per Annexure 3.
10. Out of the Tuition Fees Collected, the Second Party has to make the necessary payment to the First party as per the table given below:

Course/Program	Amount
B.Com (Honours) Integrated with ACCA	INR 36,000 Per Student for entire three years
First Installment - After admission confirmation and course commencement in 2020	INR 18,000
Second Installment – Before February 28, 2021	INR 18,000

*This is for the Batch of 2020-2021 while the same will continue for subsequent fresh batches. The above fee will be a part of the college fee.*



11. The complete list of Students of the course shall be provided to the First Party by the Second Party. Changes in Students, if any, shall be communicated by the representative of the Second Party to the First Party immediately.
12. It is intended that the terms of this MoU will remain in force for an initial period of three years set out above i.e., the completion of First Batch or is otherwise terminated in accordance with the provisions of Clause 13. The MoU can be extended for further periods after the expiry of three years upon the parties mutually agreeing such extension in writing. The terms of this Memorandum may be modified at any time by both parties on mutual consent.
13. Either party shall be entitled to terminate the MOU on 60 days' notice. The MoU will automatically terminate:
  - Any potential Binding Agreement would be unenforceable, void or illegal due to any statutory or regulatory requirements; or
  - Terminates any Binding Agreement for cause.
  - In the event of the termination of the agreement, the First Party agrees to complete the existing batches on agreed terms.
14. All intellectual property created by a party in connection with the collaboration shall remain the property of that party. The parties agree that any material jointly created by the parties for the collaboration shall be jointly owned (in equal proportions) by the parties, unless otherwise agreed in writing.
15. Where the collaboration reasonably requires the use by one party of intellectual property that is owned by the other party (the "IPR Owner"), the IPR Owner will license such rights to the other party on a non-exclusive basis, without the right to sub-license, solely for the purpose and to the extent necessary in connection with the collaboration. Any such license will automatically terminate when the MoU is terminated.





16. The college will comply by providing the required documents for ACCA Accreditation, academic program guide with details of the Integrated syllabi and sample question papers.
17. For the purposes of this MoU, "Confidential Information" shall be all information of a confidential nature (whether written or oral) concerning the business and affairs of either party which is obtained or received as a result of the discussions leading up to, the entering into or the performance of this MoU, including financial information, training & learning material, trade secrets, college lists, trade and commercial details and computer software and databases, the contents of all reports and documentation prepared by either party or on its behalf and any other information of a confidential nature designated by a party as confidential; Each of the parties shall at all times while this MoU remains in force and after it has terminated, keep confidential the Confidential Information except where:
- The Confidential Information was already lawfully known, or became lawfully known to either of the parties independently;
  - Disclosure or use is necessary by either of the parties (including their employees, agents and sub-contractors) for the proper and effective performance of this MoU;
  - Disclosure is required by law to any government, governmental department, agency, regulatory or fiscal body or authority (whether national or foreign) and their authorized agents (including professional advisers);
  - The Confidential Information is disclosed, in the case of ISDC, to another member of the ISDC group of companies;
  - Each party undertakes to the other that it will not disclose or make use of, for its own benefit, any of the Confidential Information of that other party.
18. All disputes and differences of any kind whatever arising out of or in connection with this MoU shall be referred to the arbitration, and the final decision of an arbitrator Jointly appointed by both the parties to be agreed upon and appointed by both the parties, or in case of disagreement as to the appointment of a single arbitrator, two arbitrators, one to be appointed by each party and if there are two arbitrators, they shall before taking upon themselves the burden of reference appoint a third arbitrator



who shall act as Presiding Arbitrator. This submission to the arbitrators shall be deemed to be a submission to arbitration within the meaning of the **Arbitration and Conciliation Act, 1996**, or any statutory modification thereof. The award of the arbitrator or arbitrators as the case may be, shall be final and binding on the parties.


19. This MoU does not bear any legal action status. However, In case of any disputes not settled due to arbitration it will be subject to the courts of Bangalore Jurisdiction.



St. Joseph's College (Autonomous), Tiruchirappalli, Tamil Nadu, India and Daffodil International University, Dhaka, Bangladesh, aim to establish and develop a close partnership to promote academic and cultural exchanges between the two Institutions through mutual assistance, specially, in the areas of teaching and research.



This Agreement of Co-operation, upon approval of the Vice Chancellor of Daffodil International University and the Principal of St. Joseph's College (Autonomous), Tiruchirappalli, Tamil Nadu, India will serve as a general framework for institutional co-operation. It will facilitate faculty members to discuss and develop specific programs of co-operation. Each institution will designate a liaison officer to co-ordinate the application of this Agreement in the best interest of both Institutions. Co-operative relations shall be carried out through the activities such as:

- **Student Exchange:** In the case of exchange of students, each Institution will evaluate and decide on study period of the relevant student. A student, who has received a grant and fulfils the entrance level of each institution, will be treated as a fully accepted student of concerned School/Faculty/Department, with all the same rights and regulations.
- **Faculty Exchange:** The exchange of academic staff for short duration in order to share expertise and knowledge among staff and students of both institutions.
- **Research Degrees:** The provision of placements and support for Masters Students to undertake a period of research/placement at the partner institution.
- **Sharing Resources:** The acquiescence of access to the Library database, Journal and other online resources for both staff and students of each institution.
- **Summer/Winter Program:** Both institutions agree to participate in short term Summer/ Winter programs arranged by other partner institution. In this matter, partner institution will circulate the notices among students and motivate them to attend the summer program for capacity building and cross cultural education.
- **Intern Exchange:** To encourage young entrepreneurs, new graduates and young teaching assistants, both institutions will facilitate them for internship placement from partner institution.
- **Scholarship Opportunity:** Each Institution may arrange scholarship opportunity for meritorious students of partner institution and cooperate accordingly.
- **No Legal Bindings:** There is no binding and the parties acknowledge that this MoU does not place them under any legal obligation.
- **No Agency:** There shall not be any agent to be engaged or appointed by either party to this MoU for any purpose or objection of the MoU



The provisions and activities specified in this Agreement are subjected to the availability of funds and the approval of the authorities of both Institutions. A separate financial agreement to be finalized prior to any particular program and academic activities or collaboration research.

The Agreement shall take effect from the date of signing and shall be valid for an initial period of 5 (five) years. Any amendment and/or modification of this Agreement requires and the written approval of the Vice Chancellor of Daffodil International University and the Principal of St. Joseph's College shall be appended hereto. Neither Institution shall take action relative to this Agreement without consultation with the partner in this Agreement.







### **2.1 Developing research projects jointly and avail funding**

Both institutions may jointly undertake research projects/activities through sharing of research ideas, data and academic resources that can lead to joint publications, development of any product or other intended outcome. Such collaboration activities may also include joint research conferences, visitations and sabbaticals at each other's institution. Faculty from both Institutions will collaborate in the supervision of joint research in disciplines of mutual interest. All such joint research activities will be governed by the terms and conditions laid out by separate written agreement by both Institutions.

### **2.2 Exchange of academic information, materials and facilities**

Both institutions may exchange academic information, facilities, resources etc. as mutually agreed from time to time.

### **2.3 Students Exchange**

#### **2.3.1 Student Exchange Programs**

Both institutions may develop programs whereby the students of either institution can have the opportunity to study at the other institution with mutual recognition of the credit hours arising





therefrom. It is desired by both institutions that there will be significant flow of students in exchange as reciprocal. Both Institutions may facilitate for exchange students and researchers based on mutual discussion. Pursuant to the specific agreement for academic exchange, Institute of Advanced Materials, IAAM and St. Joseph's College (Autonomous), Tiruchirappalli, Tamil Nadu, India will exchange students according to the terms and conditions laid out by separate written agreement by both Institutions.

### **2.3.2 Short Courses/ Summer School**

These courses, usually two to four weeks in duration, will normally be held in spring or summer as mutually agreed. In addition to various topics on business operations and culture, the course would include meetings with business executives, and visits to various industrial and business establishments. The cost and other terms of such programs will be mutually worked out separately each year.

### **2.4 Faculty Exchange**

Both institutions agree to develop opportunities for faculty to teach courses, conduct seminars and undertake such other activities at each other's campus as mutually agreed. Visiting faculty will be provided with opportunities to observe and share teaching methods and curriculum. Institute of Advanced Materials, IAAM and St. Joseph's College (Autonomous), Tiruchirappalli, Tamil Nadu, India will exchange faculty according to the terms and conditions as mutually agreed upon.

### **2.5 Organizing/ participation in Joint symposium, seminar, conferences, workshops etc.**

Both institutions will promote their faculty participation in the conferences, conclaves and seminars organized by each other to strengthen the ties between both the institutions and may also jointly organize symposium, seminars, conferences, workshops and other programs as mutually agreed.

### **2.6 Developing articulation for twinning/joint programs allowing students to undertake part of the program/course of study at each institution.**

Both the institutions agree to work towards the development of joint program offerings and the articulation of various academic credits between the institutions as mutually agreed for various programs/courses which entitles the students to complete a part of the program of study at each institution and will be awarded the respective degree or other respective academic transcripts upon successful completion of requirements as agreed in the separate articulation agreement.

## **3. Advertising & Publicity**

Both the institutions may publicly advertise the collaboration under this MoU among students, staff etc. Where reasonably possible, in making advertisements or public announcements in relation to this MoU, each institution shall acknowledge the participation of the other institution and the contribution that other institution has made if any.





#### **4. Relationship**

Arrangement between the institutions is on a principal-to-principal basis and not to be deemed to constitute a joint venture, agency, a partnership, franchisor-franchisee or principal-agent or alike relationship under any circumstances, and Neither party shall have any right to act or assume or create or transfer any obligation on behalf of or for or to other party.

#### **5. Commencement, renewal, termination and amendment**

This MOU will come into force upon affixing of the signatures of the representatives of both institutions and will remain in effect for five (5) years. This MOU may be renewed upon its expiry, as per mutual agreement of both Institutions. If either institution wishes to terminate the MOU at the end of the five years period or in between the period of five years, it must notify the other institution not less than six months prior to the expiry of the MOU. The event of termination will not affect participants from completing their activities at the host party already initiated or ongoing unless otherwise mutually agreed. This MoU, its renewal and the actions taken under it may be reviewed at any time. Modifications to MoU may be made by mutual consent and any amendment or extension to the MoU may be formalized by the exchange of letters between the two institutions.

#### **6. Coordinators**

The Parties shall use their best endeavors to settle amicably any difference or dispute arising under or in connection with this MOU by consultation and negotiation. If a dispute cannot be settled through such consultation, upon the request of either Party with written notice to the other Party, any such dispute shall be resolved by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the parties. The place of arbitration will be city of Chennai.

## **13. TERMINATION**

- a. Termination on Notice. Either party may terminate this agreement for any reason on 90 Business Days' notice to the other party.
- b. Termination for Material Breach. Each party may terminate this agreement with immediate effect by delivering notice of the termination to the other party,
- c. The other party fails to perform, has made or makes any inaccuracy in, or otherwise materially breaches, any of its obligations, covenants, or representations

- d. The failure, inaccuracy, or breach continues for a period of 30 Business Days' after the injured party delivers notice to the breaching party reasonably detailing the breach.
- e. Termination for Insolvency. If either party becomes insolvent, bankrupt, or enters receivership, dissolution, or liquidation, the other party may terminate this agreement with immediate effect.



**Memorandum of Understanding (MoU)**

This Memorandum of Understanding (hereinafter referred to as MoU) is made on this 10<sup>th</sup> day of September 2022 by and between St. Joseph's College, Tiruchirappalli-620 002 (hereinafter called SJC/First party) an Autonomous College which is part of a Society registered under Societies Regulations Act, 1860, on the ONE PART and Rosary College of Commerce and Arts, Navelim, Goa (hereinafter called (RCCA/Second party) on the OTHER PART. The SJC and RCCA are hereinafter collectively referred to as "Parties" and individually as 'Party'

**A) The Parties**

Rosary College of Commerce and Arts, Navelim, Goa and St. Joseph's College, Trichy, Tamil Nadu wish to enter into a Memorandum of Understanding (MoU) to facilitate the development of Management Studies, Computer Application, Economics, Psychology, Accounting, Human Resource, Mathematics and Marketing departments.

They recognize their strengths in research and education in the disciplines of Management Studies, Computer Application, Economics, Psychology, Accounting, Human Resource, Mathematics and Marketing and their mutual interest in engaging in academic and research co-operation. Therefore, RCCA and SJC agree to establish a programme for academic co-operation in the areas of mutual interest and in accordance with the terms and conditions set out in this MoU.



## **B) The Objectives**

1.1.1 To foster collaboration and provide opportunity to faculty and students of both institutions and to facilitate the advancement of knowledge through academic and research collaborations.

1.2 To promote research/and quality education between the two institutions.

## **C) Areas of Collaboration**

2. RCCA and SJC, agree to explore the possibility of engaging in the following areas of collaboration:

- 2.1) Exchange of faculty and students for a short period.
  - 2.2) Exchange of undergraduate students to participate in research projects;
  - 2.3) Conducting and organizing joint workshops, seminars and symposia in areas of mutual interest;
  - 2.4) Investigating/ Exploring the possibilities for the development of mutual academic programmes of interest;
  - 2.5) Conceptualization of the research projects to be executed in collaboration on need basis;
  - 2.6) Sharing of knowledge and capacity building in areas of mutual interest.
  - 2.7) Exchange/ Sharing of best and healthy practices followed in respective institutions.
- 
1. It is understood that the implementation of any of the types of cooperation stated above shall depend upon the availability of resources and financial support of the parties concerned.
  2. Development and implementation of specific activities based on this MoU will be further negotiated and agreed between Colleges as applicable, depending on the specific project.
    - 4.1) Conduct short term courses;
    - 4.2) Conduct cultural Projects;
    - 4.2) Conduct study tours;



- 4.3) To enable Rosary College of Commerce and Arts students and St. Joseph's College, Trichy, Tamil Nadu, to maximum utilization of resources during free time probably after exams, i.e. through online courses, guest lectures, internship and other courses in the areas of interest.
- 4.4) Skills based certification courses that are left to the choice of the two parties.
- 4.5) other areas as mutually agreed upon by the parties.
- 4.6) Workshops, seminars and events.

#### **D) Intellectual Property**

- 3. Should the collaborative research activities under this MoU result in any potential for intellectual property, each shall seek an equitable and fair agreement as to ownership and other property interests that may arise according to the rules and regulations of the two institutions.

#### **E) Coordination**

- 4. Rosary College of Commerce and Arts, Navelim and St. Joseph's College, Trichy, shall name a coordinating Committee consisting of teaching/ research staff and (a) Acting Principal of Rosary College of Commerce and Arts, Navelim or his nominee, (b) Principal of St. Joseph's College or his nominee, (c) Coordinator from Rosary College of Commerce and Arts (d) Coordinator from St. Joseph's College, will periodically review and identify ways to strengthen cooperation between the two institution.

#### **F) Activities for Immediate future**

- 5. A team of faculty research staff from St. Joseph's College and Rosary College of Commerce and Arts, will make it a priority to visit each other's Institute for a short duration for the purpose of conducting workshops, discussions and interacting with each other for the development of mutual Diploma Certificate Courses and research collaborations.



6. A select group of students from both Institutions will visit the collaborating institutions to study possible research areas, or to conduct research activity or academic pursuit.

#### **G) Terms and Termination**

7. This MoU will take effect for the date it is signed by representatives of the two institutions. It will remain valid for the period of five years, and may be continued after a suitable review and mutual agreement.
8. This MoU may, at any time during its period of validity, be terminated by one of the parties upon prior notice to the other in writing not later than six months before the termination date. Once terminated, neither Rosary College of Commerce and Arts nor St. Joseph's College will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, Rosary College of Commerce and Arts and St. Joseph's College will ensure that all activities in progress are allowed to complete successfully.
9. Any cooperation under this MoU is subject to the availability of funding sources.
10. In the event that either party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MoU, the disclosing party shall have prior written consent from the other party.
11. Any dispute concerning the interpretation and /or application of this MoU shall be settled amicably through consultation between the parties.
12. This MoU may be amended or revised at any time by mutual written consent of the parties, and such amendment shall form an integral part of this MoU.




## H) General

**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
ST. JOSEPH'S COLLEGE, TIRUCHIRAPPALLI, INDIA  
AND  
NANZAN UNIVERSITY, JAPAN**

St. Joseph's College, Tiruchirappalli, Tamil Nadu, India (hereafter referred to as "SJC") and Nanzan University, Nagoya, Japan (hereafter referred to as "NU") enter into this Memorandum of Understanding ("MOU") for the purpose of strengthening, expanding and enriching cooperation in higher education that will make collaborative programs and activities possible. SJC and NU are referred to individually as a "Party" and collectively as the "Parties."

Collaborative programs and activities may include the following:

- Exchange of faculty for teaching, including joint research and development projects
- Exchange of students
- Exchange of research output and materials in fields of mutual interest; and
- Participation in joint international conferences, seminars, lectures, various forms of faculty training and development, and similar academic meetings.

The specific terms of this MOU do not preclude the development of future collaborative ventures or projects not mentioned in this document.

This MOU implies that activities to be started in order to realize the aforementioned objectives shall be determined in each case through a particular Supplemental Agreement in accordance with the rules and regulations of each Party, and subject to available funding sources on the part of each of the two Parties. Each Supplemental Agreement will be appended to this MOU as a schedule, and the terms of the Supplemental Agreement will control the administration of the activity described. To the extent that the MOU and the Supplemental Agreement are ever determined to be inconsistent, the language of the Supplemental Agreement shall be deemed controlling for the purposes of the activity described in that Supplemental Agreement.



Representatives of the Parties to this MOU shall consult each other at periodic intervals to review the implementation of collaborative programs and to propose other mutually beneficial programs. Any amendment or modification of the terms in this MOU shall be done only by means of a written agreement signed by both Parties.

This MOU shall become effective on the day both Parties have signed the document, and shall remain in effect for five (5) years from that date or until terminated in writing by the Parties hereto, whichever shall come first. It will be automatically renewed every five years unless either Party notifies the other of its intent to terminate. Upon any such termination, any activity that may have commenced at either Party pursuant to a Supplemental Agreement before the effective date of termination may be completed, and the applicable terms of the MOU and the applicable Supplemental Agreement shall continue to govern the activity.

This MOU constitutes the entire agreement between the Parties and supersedes all prior discussions, agreements, and understandings, whether verbal or in writing.

Each Party shall designate a person or office to serve as liaison for implementing this MOU. For SJC, the contact person will be Rev. Fr. Principal or his/her designee. For NU, the contact person will be the Director of the Center for International Affairs or his/her designee.

Any notice to either Party hereunder must be in writing signed by the Party giving it, and shall be served either personally or by registered or certified mail, or by overnight or expedited delivery service, addressed as follows:




