While initiating the proceedings, Rev. Dr. Leonard Fernando S.J sought the blessing of God Almighty since the college is going to inaugurate its Dodransbicentennial Celebrations. He emphasized the words of Superior General of Jesuits, Rev. Dr. Arturo Sosa S.J that intellectual work requires absolute effort and dedication. He also appreciates the applications developed by the students in the joint venture of Swatch Barath in order to serve the society which is the primary mission of the Jesuits.

Dr. N. Ravi, Dean, School of Physical Sciences presented the minutes of the 51st Governing Body Meeting that was held on 27th February 2018. Fr. Secretary pointed out that the matters pertaining to the semester question paper pattern in B.Com which was raised by Dr. Charlaas ,HoD of Commerce Department, during 51st Governing Body meeting was not explained clearly in the minutes. He also mentioned that there is no board of studies for Schools so it has to be mentioned Board of Studies of the department. Fr. Rector underlined that the department of foundation course has to be mentioned as Department of Human excellence. Taking up the corrections, the minutes of the 51st Governing body were passed.

Dr. G. Beschi, Dean of School of Languages and Culture read out the minutes of 42nd Academic Council Meeting held on 11th April 2018. It was passed after the approval.

Rev. Dr. L. Arockiam, S.J, Dean, School of Management Studies presented the recording matters pertaining to the academic activities by giving the details of the students admitted in the academic year 2017-2018.

Dr A. Paulraj, the Controller of Examinations, presented a detailed report on students' performance in semester examinations in April 2018. He noted that the results trend among the various UG programs are improving over the semesters. A striking feature to be noted is that most of the PG programs fall in the descriptor A. The pass percentage has shown an upward trend in higher semesters compared to II semester which is a sign of continuous improvement shown by the students and competence of the faculty members.

At this juncture, Rev. Fr. Rector appreciated both staff and students for showing involvement in teaching and learning which is evident in the result of the academic year.

Rev. Fr. Secretary enquired the reason for the large number of failures in Semester II.

Fr. Principal clarified that the shift from the school to college affects the students and moreover most of them were from Tamil medium so they need time to improve and they show considerable improvement in the V and VI semester.

Fr. Aruldoss pointed out the low results and unruliness of the students in the second year and Dr. V. Sujatha, Eminent Expert said it is the general phenomena in all the colleges and the students will become more focused in the final year. Fr. Rector urged the members to take some initiative to make the students to have more focus in their studies in III semester and Fr. Principal told the HODs concern have to take care of it and proper counseling must be given for the students.

Fr. Secretary showed his concern over the slackness shown towards foundation course exams by the students. Dr. S. Joseph Arul Jayraj pointed out that since the marks of the foundation course were not taken for overall percentage, the students are lethargic.

Dr. L. Arockiam Dean-School of Computing Sciences read out the details of Ph. D. Registration during 2017-2018. Dr. S. Joseph Arul Jayraj stated that admissions for other state students can be restricted for PhD since, a large number of them are admitted, they curb the opportunity of our students. Dr. V. Sujatha, Eminent Expert also seconded it. Fr. Principal asked the PhD guides to admit at least one student with JRF scholarship. Dr S. Alfred Cecil Raj, Dean-IQAC, pointed out that number of guides in the Department of Biotechnology is given wrongly in the list (5 or 6)and he also said that the number of guides in MBA can be added in the list.

Dr. S. R. Senthilkumar, Dean, School of Biological Sciences read out the financial Expenditure, receipt of UGC funds and approval of Autonomy Grant Budget. Rev. Fr. K. Royappan S.J, Treasurer, presented the Endowments scholarships and details of scholarships received by the students. Fr. Secretary presented the main financial statement and all the three were approved by the board.

Fr. Secretary mentioned the legal procedures undertaken by the institution regarding the appointment of teaching and non teaching staff members and also mentioned that the case was filed for the appointments of 2017 batch.

Dr. I. Arul Rayappan, Staff Representative read out the list of various committees and it was approved.

Rev. Dr. C. Joe Arun S.J, Director, JIM, presented the report of the JIM. He mentioned about the new curriculum, startup ideas and Annual Faculty Retreat. He also stated that the admission has increased and more number of engineers has been admitted. Dr. V. Sujatha, Eminent Expert, insisted on the establishment of the incubation. She also recommended taking students to IIT Chennai for their learning about incubation. Fr. C. Joe Arun clarified that with the help of Dr. Muthusingaram the Director of IIT, JIM is conducting its placement interviews and he also comes twice in a year to validate the process of the students. Dr. V. Sujatha insisted on having Campus Company. Fr. C. Joe Arun mentioned that JIM is in the process of starting incubation with the help of Dr. Muthusingaram the Director of IIT.

Fr. Principal was happy to announce that RUSA has announced Rs. 2 Cr for the college and UGC has given approval for the extension of VISCOM department.
