Depending on your bank, payment may be made online, in person, or over the phone. For debit/ credit card payments, enter your card details online to complete your payment in your home currency.
- 5. Please use the official Flywire receipt as proof of tuition payment. This receipt should be used for the visa application.
- 6. For all payments made outside of Canada using Flywire, please note that if a refund is required, the funds will be returned to the originating source (i.e. person making the payment). Therefore, it is advisable for students not to make payments through an Agent for this reason.

It is your responsibility to ensure that you have the correct immigration documents necessary to begin your studies at Algonquin College. If your Study Permit is refused or delayed, we require notification in writing before the start of classes to avoid a withdrawal penalty. Please note that the last day to start your program is five (5) days after the start of class, and that there are no refunds for withdrawals made after ten (10) days of class.
