PROVISIONAL OFFER FOR APPOINTMENT AS PROBATIONARY CLERK

Greetings from Tamilnad Mercantile Bank Ltd., This is with reference to the personal interview held on 18.06.2023, at Madurai. We are pleased to offer you the **provisional appointment** as probationary clerk on the following terms and conditions:

Salary and other Emoluments:

- 1. The emoluments during the period of probation will be Salary ₹27,000/- and other allowance of ₹6,750/- (at present 25% of Salary). The present total fixed pay is ₹33,750/- per month.
